WAIVER AND RELEASE OF LIABILITY FORM

THIS FORM MUST BE COMPLETED BEFORE ANY ACTIVITY OR EVENT

LIABILITY WAIVER

For and in consideration of Emmanuel Grace Baptist Church, EGBC (the “**Organization**”) allowing me, the undersigned, to participate in any capacity in an Organization sanctioned, licensed or approved event or activity (“**Event**”); I, for myself, and on behalf of my guest, spouse, children, heirs and next of kin, and any legal and personal representatives, executors, administrators, successors, and assigns, hereby agree to make the following contractual representatives pursuant to this Agreement (the “**Agreement**”):

A. RULES AND REGULATIONS: I hereby agree to abide by the rules, regulations, and policies of the Organization, including any and all COVID-19 related safety measures required by the Organization.

I certify that I am in good health and have no physical or other impediment which would endanger me while attending this Event. I will not be under the influence of drugs or alcohol, which would impair my ability. I acknowledge and agree this Event has inherent risks. I have full knowledge of the nature and extent of all the risks associated with this Event.

B. ACKNOWLEDGMENT OF RISK: I knowingly, willingly, and voluntarily acknowledge the inherent risks associated with social gatherings and that participation in any Organization involves risks and dangers including, without limitation, sickness and disease (including COVID-19 and communicable diseases, in addition to other undefined, not readily foreseeable and presently unknown risks and dangers (“**Risks**”).

C. ASSUMPTION OF RISK: I understand that the aforementioned Risks may be caused in whole or in part or result directly or indirectly from the negligence of my actions or inactions, the actions or inactions of others attending this Event, or the negligent acts or omissions of the Released Parties defined below, and I hereby voluntarily and knowingly assume all such Risks and responsibility for any damages, liabilities, losses, or expenses that I incur as a result of my participation in this Event. I also agree to be responsible for any injury or damage caused by me or any persons under my direction and control at this Event.

D. RELEASE: In consideration of my participation in this activity, I agree (on behalf of myself, my heirs, executors, administrators, and assigns) to release, discharge, waive and relinquish **Emmanuel Grace Baptist Church** (or its officers, agents, employees and volunteers) from any and all liabilities, claims, or actions for personal injury, property damage, or wrongful death which may arise out of my participation.

E. COMPLETE AGREEMENT AND SEVERABILITY CLAUSE:

I HAVE CAREFULLY READ BOTH FRONT AND BACK OF THIS AGREEMENT, WAIVER AND RELEASE AND FULLY UNDERSTAND ITS CONTENTS. I AM AWARE THAT THIS IS A RELEASE OF LIABILITY, AND KNOW IT CONTAINS AN ASSUMPTION OF RISK, RELEASE, AND WAIVER FROM LIABILITY.

THIS CONTRACT IS BETWEEN MYSELF AND EMMANUEL GRACE BAPTIST CHURCH AND I SIGN IT OF MY OWN FREE WILL.
